

# **Privacy Policy**

Adam Kopeć ("us", "we", or "our") operates <a href="https://thecloudsolutions.de">https://thecloudsolutions.de</a>, Cloud Server desktop application and Cloud applications (the "Service"). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Service.

We use your Personal Information only for providing and improving the Service. We will never sell nor use any information we obtain from you, including Personal Information, for any tracking purposes.

By using the Service, you agree to the collection and use of information in accordance with this policy.

#### **Information Collection And Use**

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to your name and email address ("Personal Information").

We use the collected data for various purposes:

- To provide and maintain our Service
- To notify you about changes to our Service
- To allow you to participate in interactive features of our Service, but only when you choose to do so
- To provide customer support
- To gather analysis or information so that we can improve our Service
- To monitor the usage of our Service
- To detect, prevent and address technical issues

#### **Retention of Data**

Adam Kopeć will retain your Personal Information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Information to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

#### **Disclosure Of Data**

If Adam Kopeć is involved in a merger, acquisition or asset sale, your Personal Information may be transferred. We will provide notice before your Personal Information is transferred and becomes subject to a different Privacy Policy.

#### **Disclosure for Law Enforcement**

Under certain circumstances, Adam Kopeć may be required to disclose your Personal Information if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

## **Legal Requirements**

Adam Kopeć may disclose your Personal Information in the good faith belief that such action is necessary to:

- To protect the personal safety of users of the Service or the public
- To protect against legal liability

#### **Transfer Of Data**

Your information, including Personal Information, may be transferred to — and maintained on — computers located inside of Germany, which may be outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

Adam Kopeć will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Information will take place to an organisation or a country unless there are adequate controls in place including the security of your data and other personal information.

#### **Purchases**

We may provide paid products and/or services within the Service. In that case, we use third-party services for payment processing (e.g. payment processors).

We will not store or collect your payment card details. That information is provided directly to our third-party payment processors whose use of your personal information is governed by their Privacy Policy. These payment processors adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of payment information.

## Log Data

We may collect some of the information that your browser or our applications send whenever you visit or connect to the website available as part of our Service ("Log Data").

#### **Service Providers**

These third parties have access to your Personal Information only to perform these tasks on our behalf and are obligated not to disclose or use it for any other purpose.
